A Learning Community in LTC

A long-term care Learning Community was established for (LC-LTC) at Vancouver Coastal in 2021, comprising of the professional practice team, directors of care, managers, medical leaders, quality improvement and data analytics experts. This Regional team meets biweekly to discuss barriers and facilitators to new and ongoing initiatives that align with the local and regional priorities. The LC-LTC also engages in research and quality improvement initiatives in partnership with patients, families, researchers and trainees.

Create a safe environment for people with lived and living experiences to contribute to the quality improvement work.

Informed Consent in an LHS

The VCH privacy, LHS, and research administration teams are exploring ways to improve the informed consent process to facilitate research that informs routine practice to move forward more easily. Processes such as metaconsent exist for LHS elsewhere. However, local administrative and operational considerations have to come into play in creating a sustainable process that removes barriers to research and protects privacy and confidentiality for research participants at the same time.

We need Indigenous representation on research ethics boards.

The Covid-19 Therapeutics Committee

A team of 40+ physicians, pharmacists and researchers convened in March 2020 to critically assess the emerging scientific literature on potential Covid-19 therapies. The group met weekly to discuss clinical trials and their conclusions informed a continuously updated infographic on the BCCDC* website and was distributed to physicians across the province to support patient care. The group continues to this day to provide evidence synthesis to inform Covid-19 care.

[We need] a better way to connect the research group with health authorities ... planning research questions together.

Post-Covid-19 Clinical Care Network

The Post-Covid-19 Interdisciplinary Clinical Care Network (PC-ICCN), established in 2020, offers care for patients, education for clinicians and research for long Covid. The PC-ICCN leverages a central Patient Records and Outcome Management Information System (PROMIS) database used by the BC Provincial Renal Agency to serve as the electronic health record system, data repository, and patient registry. Data from PC-ICCN are used to examine patient symptom patterns, identify biomarkers, and validate instruments.

Data and real-time data are now used in Urgent Care ... reduce[ing] the number of people that are coming back.

A New LHS Team at VCH

VCH established a role and team in 2022 to advance Learning Health Systems for community health services, public health, and Indigenous health. The first of its kind in British Columbia, this team is finding ways to foster an enabling environment, where teams are supported in closing the gap between knowledge and practice. This requires both incremental changes and broad policies that enable learning cycles for continuous quality improvement.

Matriarch Advisory Counsel (MAC)

MAC is a learning community of Indigenous Elders, matriarchs, and clinicians across VCH, who advise programs and guide research on Indigenous women's and children's health. For example, the MAC has been engaged in a perinatal substance use program, where they are providing guidance on how to support pregnant Indigenous Peoples actively using substances with perinatal healthcare access. More specifically, they have been advising on healthcare processes and services that should be provided to ensure that health care services are more culturally safe.

We are not comfortable talking about our trauma even if we have been doing this for many years.

The onus is on us all to be used to feeling uncomfortable.
